ORDER

In pursuance of W.T.Message No. **DS.88/2013/10** dated **18/04/2013** received from the Director, FCS & CA, Assam, Guwahati communicating allocation of total **3960.00 Qtls.of APL Rice** for this Sub-Division for the month of **May/2013**, the sub-allocation of the same has been made to the following GPSS and FPS of this Sub-Division. The allottee will deposit value of rice within **15 th May /2013 for the month of May 2013** and will lift the same within **20th May 2013** for ultimate distribution to the APL consumers under PDS as uniform distribution **@4.851 kgs. per FIC per month both of Rural and Urban area** at Govt. Fixed rate .The allottee GPSS/FP shops will submit arrival report to the concerned Area Officer within 24 hours of lifting for verification.

The allottee GPSS/FP shops will not issue APL Rice(Regular) to the Tea Garden Labourers in the Tea Growing district by over lap of population as they have been sub-allocated food grains separately by the Director,FCS & CA, Assam, Vide No.DS.88/2013/9 dated 18-04-2013.
