The sub-allocation of the same amongst GPSS/ F.P.Shop is made as follows. The allottee will deposit value of Iodised Salt and lift the same within 31 st **May/2013** for ultimate distribution amongst the consumers under PDS @ **911 Grams** per head per month at Govt fixed rate. The allottee will submit arrival report within 24 Hours of lifting and monthly return within 3 rd day of the proceeding month.
